Description

CRJU 140 – 3 Credits – Police Administration explores the administration of police agencies and the management of their hierarchical components. Additionally, it examines the internal structure of the police organization and the functions that deal directly with the public.

Overall Course Objectives

Upon completion of this course the student will be able to:

1. describe the history of modern police agencies;
2. summarize basic concepts of police management;
3. evaluate organizational structures of police agencies;
4. analyze the roles of research, planning and budgeting in police administration;
5. examine the function and necessity of police vehicles and personnel equipment;
6. assess the management of police property and evidence;
7. explain the management of human resources in policing;
8. explain the administration of patrol operations;
9. examine traffic law enforcement administration;
10. describe the administration of criminal investigations; and
11. analyze the evolution of community policing.
