Description

CRJU 153 – 3 credits - Private Investigation introduces students to the field of private investigation and its relationship to the criminal justice system. Emphasis is placed on local and national licensing regulations, scope of operations, legal considerations, civil law, and professional ethics.

Overall Course Objectives

Upon completion of this course the students will be able to:

- 1. define the qualities and skills of a private investigator;
- 2. evaluate ethical decisions in accordance with the rules governing private investigators;
- 3. explain licensing requirements for private investigators;
- 4. identify the sources of employment for the private investigator and investigative agency;
- 5. distinguish between civil and criminal law;
- 6. analyze lawful and ethical business practices;
- 7. identify lawful sources of public and private information;
- 8. demonstrate methods to conduct lawful video, foot, fixed and mobile surveillances;
- 9. design a comprehensive case management file;
- 10. describe the collection and recording of evidence for court presentation;
- 11. interview witnesses and suspects;
- 12. organize investigative field notes and write a concise investigative report; and
- 13. prepare evidence to be used in a court or administrative hearing.
