Description

NURN 217 – **Mental Health Nursing Concepts**: students examine the nursing care of clients, families, and groups to meet the emotional, behavioral, and social demands of life. Emphasis is placed on the concepts of addiction, clinical judgment, cognition, health care law, human development, mood/affect, nutrition, professionalism, and trauma through didactic and clinical experiences.

Pre-requisites: NURN 160 (with grade of C or higher)

Overall Course Objectives

Upon completion of this course, students will be able to:

- 1. implement nursing care that promotes and maintains safety for clients with mental health disorders;
- 2. perform milieu management and treatment in the least restrictive environment;
- 3. adapt professional practice responsibilities and standards within a therapeutic milieu when caring for clients with mental health disorders;
- 4. apply clinical judgment when using the nursing process with disorders of addiction, cognition, human development, mood/affect, nutrition, and trauma;
- 5. apply knowledge of mental health nursing assessment to conduct a mental status exam;
- 6. use current research and evidence when planning care for clients with disturbances of addiction, cognition, human development, mood/affect, nutrition, and trauma;
- 7. evaluate the essential pharmacologic interventions for clients with problems of addiction, cognition, human development, mood/affect, nutrition, and trauma;
- 8. complete a comprehensive self-evaluation that emphasizes effective communication techniques and caring behaviors to show clinical and professional growth;
- 9. perform health promotion and teaching activities that contribute to optimizing the mental health of clients and groups; and
- 10. discuss mental health issues that have significant impact on clients, families, society and the nursing profession.
