Common Course Outline OCTA 221 Psychosocial Dysfunction I 3 Semester Hours

Description

OCTA 221-3 Credits-Psychosocial Dysfunction I introduces the major psychosocial issues common to each developmental period across the lifespan and the onset of mental illness common to certain developmental periods; discusses psychiatric diagnoses treated by occupational therapy practitioners; uses lectures, videotapes, case studies and group discussion.

3 credits: 3 lecture hours each week

Prerequisite: Admission to Occupational Therapy Assistant Program

Overall course objectives

Upon completion of this course the student will be able to:

- 1. Define and differentiate mental health and mental illness;
- 2. Incorporate the importance of occupation when identifying and discussing issues affecting the practice of psychosocial occupational therapy;
- 3. Define a therapeutic milieu;
- 4. Identify major definitions, components and assumptions of Freud, Erikson, Rogers, Skinner, Havighurst, Piaget, Llorens, Mosey, Fidler, Reilly, Allen and Keilhofner, King;
- 5. Define the normal sequence of developmental factors (family, age, gender, culture);
- 6. Identify mental disorders that occur at various points of development;
- 7. Identify signs and symptoms of various mental illnesses;
- 8. Identify the impact of symptoms on functional performance;
- 9. Differentiate various psychiatric diagnoses;
- 10. Define classifications of medications prescribed to treat psychiatric disorders;
- 11. Identify side effects and techniques to observe side effects of these medications.
