Common Course Outline POLS 105

State and Local Government and Politics 3 Credits

Description

POLS 105 - State and Local Government and Politics introduces students to the systematic study of government, politics and the legislative process. Students analyze the foundation, development, and exercise of executive power at the state, and local levels of government. Students examine the structure of state courts and their role in government, and study how state and local government affects their lives, jobs, and community. This course gives special attention to Maryland and Baltimore County Governments.

Overall Course Objectives

Upon successful completion of this course, students will be able to:

- 1. demonstrate how to interact with state and local governments in order to solve problems and receive services;
- 2. simulate the process of how bills become laws in the Maryland legislature through a classroom mock legislature;
- 3. explain how various states approach civil and voting rights;
- 4. outline how Maryland and Baltimore County governments are different from other state and local governments;
- 5. summarize the different forms of county and local governments in Maryland;
- 6. describe the structure of Maryland courts and how individuals become judges;
- 7. identify the functions of the American federal system of government at the state and local levels, and the relationships between them;
- 8. identify the major features of American State Government Constitutions and explain the role of these constitutions in structuring state and local governments;
- 9. discuss how citizens participate in state and local politics, including the importance of public opinion, mass media, voting, and political interest groups;
- 10. compare and contrast the organization and roles of political parties in influencing state and local politics, elections and government;
- 11. analyze the roles of political interest groups in influencing state and local politics and government;
- 12. evaluate the roles and powers of state governors, mayors, and county executives in leading state and local governments;

- 13. explain the structure and functions of typical state and local executive and administrative agencies;
- 14. interpret issues and events affecting the current state and local political environment; and
- 15. evaluate the credibility of sources based on criteria discussed in class.
