## LGST 206

### Family Law

3 Credits

## Community College of Baltimore County

### Description

**LGST 206 – Family Law** introduces students to Maryland’s domestic law. Topics covered in this course include marriage and divorce, as well as the related issues of child support, custody and alimony. Students gain an understanding of Maryland’s laws related to guardianship, adoption, paternity, and children in need of assistance. Students gain experience preparing family court pleadings and motions, among other related documents.

### **3 Credits**

**Prerequisite:** ACLT 052 or ACLT 053 or (ESOL 052 and ESOL 054)

### Overall Course Objectives

Upon completion of this course students will be able to:

1. discuss the role of a paralegal in a domestic practice;
2. distinguish among void, voidable and valid marriages;
3. explain the grounds for annulment, legal and religious;
4. distinguish between limited and absolute divorce;
5. evaluate the concept of corroboration and the defenses of reconciliation, condonation, and recrimination;
6. examine the domestic violence petition process;
7. apply the best interests of the child standard in custody and visitation, using case law, statutory law and the litigation process in custody litigation;
8. apply the Maryland Child Support Guidelines to calculate support using the sole and shared physical custody worksheets;
9. examine the support of adult dependent children;
10. identify methods of enforcement for non-support;
11. analyze factors for indefinite and rehabilitative alimony;
12. examine the issue of marital property and the court's role in the division of such property;
13. analyze the elements of a valid separation agreement and a valid pre-nuptial agreement;
14. discuss paternity statutes and related litigation;
15. evaluate the factors involved in the adjudication of Child in Need of Assistance (CINA) cases; and
16. discuss the ‘best interests of the child’ standard in adoptions.

### **Course Requirements**
