# CRJU 153 Private Investigation

3 Credits

# **Description**

**CRJU 153 – Private Investigation:** introduces students to the field of private investigation and its relationship to the criminal justice system. Emphasis is placed on local and national licensing regulations, scope of operations, legal considerations, civil law, and professional ethics. This is a writing-focused course, which means writing will be used as a tool to enhance the student's learning, composition, and research skills. The career in private investigations requires documenting each investigative step on a variety of reports, such as, activity reports, surveillance reports, contracts, research, letters, freedom of information requests, marketing materials, notes, and investigative plans. In the field, any documentation produced is shared with clients, government agencies and the judicial system. Developing one's writing skills will improve communication, court testimony and professional standards.

Prerequisite: ACLT 053 or (ESOL 052 and ESOL 054)

# **Overall Course Objectives**

Upon completion of this course, students will be able to:

- 1. define the qualities and skills of a private investigator;
- 2. identify the ethical guidelines in accordance with the rules governing private investigators;
- 3. explain licensing requirements for private investigators;
- 4. identify the sources of employment for the private investigator and investigative agency:
- 5. distinguish between civil and criminal law;
- 6. analyze lawful and ethical business practices;
- 7. identify lawful sources of public and private information;
- 8. demonstrate methods to conduct lawful video, foot, fixed and mobile surveillances;
- 9. design a comprehensive case management file;
- 10. design the collection and recording of evidence for court presentation;
- 11. interview witnesses and suspects;
- 12. organize investigative field notes and write a concise investigative report; and
- 13. prepare evidence to be used in a court or administrative hearing.
