Mortuary Law and Practices I

2 Credits (2 Lecture hours per week)

Community College of Baltimore County Common Course Outline

Description

MORS 141 – Mortuary Law and Practices I: introduces the student to sources of law; covers state and federal laws and regulations pertaining to a funeral service and the legal aspects of being a licensed funeral director/mortician. Offered in the Fall semester only.

Pre-requisites: MORS 106, BIOL 130, BIOL 245, and BIOL 252 with a C or better

Overall Course Objectives

Upon completion of this course, students will be able to:

- 1. identify legal relationships, rights, duties, and liabilities between the funeral director and/or embalmer, the dead body, and the consumer;
- 2. explain the legal issues in order to avoid liability;
- 3. identify the federal and state laws, rules and regulations affecting funeral service;
- 4. identify the various documents which are required in funeral service; and
- 5. recognize situations when legal and other professional services are required for death planning and estate administration.
