Description

OCTA 266 - General Fieldwork: students participate in a supervised fieldwork experience to facilitate the development of competency as an entry level occupational therapy assistant. The student will collaborate with a diverse client/patient population in various clinical settings. Students participate in aspects of the evaluation, treatment, documentation, and selected business processes of the site.

Pre-requisites: OCTA 227; OCTA 231; OCTA 236; and OCTA 240

Overall Course Objectives

Upon completion of this course, students will be able to:

- 1. demonstrate gathering data and developing/implementing a treatment plan for common diagnoses at the given site;
- 2. demonstrate, in collaboration with the occupational therapist, data collection from observations, medical records, and interviews;
- 3. perform standardized and non-standardized assessments in accordance with established guidelines and procedures;
- 4. modify treatment approaches to meet the patient/client's physical and psychosocial needs;
- 5. document and communicate assessment results and treatment outcomes to meet productivity and reimbursement standards;
- 6. demonstrate intra-professional and inter-professional collaboration with the treatment team;
- 7. articulate to the occupational therapist clinical reasoning used in the selection of treatment activities;
- 8. implement evidenced-based treatment to promote independence in occupational performance areas;
- 9. apply selective modalities under supervision of the occupational therapist;
- 10. modify select technologies based on client need and resource availability;
- 11. engage patients/clients/families/caregivers in the treatment process;
- 12. collaborate with the occupational therapist in the re-assessment and discharge process;
- 13. provide patient/client education, training, and community resources/referrals as needed:
- 14. explain the operation of the site; and
- 15. demonstrate ethical and professional behaviors.

Course Requirements

Grading is determined by the individual faculty member, but shall include the following at minimum:

- passing score on American Occupational Therapy Association (AOTA) Fieldwork Performance Evaluation (FWPE) for the Occupational Therapy Assistant Student. The on-site clinical supervisor evaluates Student's Performance.
- completion of parts 1 and 2 of the Student Evaluation of the Fieldwork Experience (SEFWE) surveys.
- additional assignments as required by site clinical educator
