Description

SLWK/HUSC 202 – Human Behavior in the Social Environment: is a course that offers students an introduction to understanding human behavior and its development across the lifespan. This course integrates theories of human development with a focus on social contexts. NOTE: SLWK 202 is the same as HUSC 202. Earn credit for one only.

Pre-requisites: HUSC 101, or completion of SLWK 200 with a minimum grade of C

Overall Course Objectives

Upon completion of this course, students will be able to:

- 1. examine interrelated aspects of growth and development across the lifespan, including biological, cognitive, social, emotional, and spiritual dimensions;
- 2. assess theories of lifespan development and human behavior;
- 3. review social policies at the local, state, and federal level that impact well-being, service delivery, and access to social services;
- 4. investigate how cultural beliefs, social values, and oppression affect our development, our perceptions of self and others, and interpersonal relationships;
- 5. explore internal and external factors influencing development across the lifespan;
- 6. demonstrate the values of the social work profession orally and in writing;
- 7. demonstrate the importance of diversity in shaping life experiences across the micro, mezzo, and macro levels of practice;
- 8. reflect upon social, economic, and environmental justice to advocate for human rights at the individual and system levels; and
- 9. apply relevant laws, regulations, Codes of Ethics, and models of ethical decision making to ethical dilemmas across a variety of settings.

- IV. Personal values and cultural mores
- V. Professional values of the social worker
- VI. Social, economic, and environmental justice

Course Requirements

- an observational research project and presentation
- a biopsychosocial assessment of a case study

Written assignments and research projects: students are required to use appropriate academic resources in their research and cite sources using APA Style.
